which is supported by affidavit of learned counsel for the appellants, delay in re-filing the accompanying appeal is condoned, while making it clear that for the period of delay, appellants shall not be granted interest in the event of their succeeding in the appeal.

With aforesaid observations, this application is disposed of.

## LA.APP. 131/2012

The instant appeal relates to Village – Pochanpur, where vide Notification of 13<sup>th</sup> December, 2000, the land of the appellants stood acquired under Section 4 of the Land Acquisition Act, 1894 and the Reference Court vide impugned order of 8<sup>th</sup> March, 2010, while upholding the compensation amount awarded by the Land Acquisition Collector to the appellant, has denied any enhancement thereupon.

Mr. Sanjay Kumar Pathak, learned counsel for the respondent No.1- UOI, states that the subject matter of this appeal stands covered by the decision of this Court in LA.APP No. 1195/2008 'Ranbir Sharma Vs. Union of India & Anr.' rendered on 6<sup>th</sup> January, 2012, wherein compensation amount in respect of lands acquired in Village Pochanpur has been enhanced to ₹16,50,000/- per acre for the Category 'A' lands and to ₹14,69,600/- per acre in respect of Category 'B' lands.

Counsel for the appellant fairly concedes that case of the appellant is at par with *Ranbir Sharma (Supra)*.

In the light of above, this appeal is allowed in terms of decision of this Court in *Ranbir Sharma (Supra)*, with statutory benefits and proportionate costs, while declining interest for the

period of delay.

This appeal stands disposed of in aforesaid terms.
