ORAL ORDER

2 24-12-2013 Heard learned counsel for the petitioners and learned
Additional Public Prosecutor for the State.

The petitioners apprehend arrest in a case registered for the
offence punishable under Sections 498-A and 376 of the Indian
Penal Code.

Petitioners No. 2 and 3 are the sisters of the husband of the
complainant whereas petitioner No. 1 is the husband of petitioner
No. 2.

Learned counsel appearing on behalf of the petitioners
contends that from bare reading of the complaint case, it will

appear that the same is malicious and the prosecution story is highly improbable. He submits that there is no specific allegation against petitioners No. 1 and 2 and the allegation against petitioner No. 3, a lady, which attracts provision of Section 376 is not believable.

In view of the facts and circumstances of the case and after perusing the complaint petition and keeping in mind the submissions advanced on behalf of the petitioners, let the above named petitioners, in the event of their arrest / surrender within six weeks from today before the Court below, be released on bail on furnishing bail bonds of Rs. 10,000/- (ten thousand) each with two sureties of the like amount, each to the satisfaction of the learned Judicial Magistrate, 1st Class, Madhubani, in connection with Complaint Case No. 412 of 2013, subject to the conditions as laid down under Section 438(2) of the Cr. P.C.
