

The present petition was filed with a prayer to



In this case, show cause has been filed on behalf of opposite parties, particularly; opposite party nos. 2 to 7, wherein; it has been indicated that order has been complied with and all retiral dues of the petitioner have already been cleared. This submission has been accepted by the learned counsel for the petitioner and by supplementary affidavit, which was filed on 25th July, 2013, the petitioner has brought on record, the speaking order passed by the Road Construction Department, Govt. of Bihar, in compliance with the order of this Court. On perusal of the same, it appears that the petitioner was even paid 5% statutory



interest.

Learned counsel for the petitioner submits that though amount in respect of leave encashment to the tune of *Rs. 3,85,515/-* (three lacs eighty five thousand five hundred & fifteen) was sanctioned, but it was paid after about six months. It was further submitted that this amount was required to be paid to the petitioner immediately after retirement, but it was not paid. Subsequently, at belated stage, this amount was paid and that too, without any interest on delayed payment. According to him, as per order of this Court, the respondents are required to pay interest on the amount of leave encashment also.

Sri Rajesh Kumar Verma, learned Standing Counsel No. 27 has opposed the prayer of the petitioner upto this extent and he submits that there is no statutory provision for payment of interest over the amount of leave encashment. He further submits that order of this Court has already been complied with.

In view of the fact that entire retiral dues have already been paid to the petitioner and also in compliance





with the order of this Court, a reasoned order has been passed, which has been brought on record, as **Annexure '4'** to the supplementary affidavit, after hearing the parties and considering the materials available on record, particularly; **Annexure '4'** to the supplementary affidavit, the Court is of the opinion that it is not a fit case for initiating contempt proceeding against the opposite parties.

The petition stands dismissed.
