**JUDGMENT AND ORDER**

This instant writ petition is directed against the non-declaration of result for Recruitment of Riflemen (Tradesmen) in Assam Rifles.

2. The petitioner's case in nut shell is that. "this writ petition has been filed by the petitioner under Article 226 of the Constitution of India for issuance of a Writ of Certiorari and mandamus for directing the Respondent Authority to giving appointment of the petitioners to the respective posts for which they had applied for and attended the Recruitment Rally held in Guwahati after declaring the results of the same. This instant Writ Petition has been filed challenging the malafide action of the Respondent authority in non declaration of the results of the said recruitment rally and nor appointing the petitioners after being declared successful candidates in all the necessary tests conducted by the respondent authority with a prayer for directing the respondent authority to appoint the petitioners to the post of Operator Radio Lines, hence this instant writ petition."

3. Mr. R Jha, the learned counsel appeared for on behalf of the petitioner has submitted that the result for Recruitment of Riflemen (Tradesmen) in the Assam Rifles was not declared, hence approached this Court by way of this instant petition.

4. Mr. SC Shyam, the learned senior CGC appeared for on behalf of the respondent produced the Departmental file before this Court pertaining to the entire proceeding of Recruitment Rally conducted on 14.09.11.

5. As per record it appears that, the petitioners namely; Raj Kumar Prajapati secured 62%, Sonu Kumar Prajapati secured 48%, Angad Kumar Yadav secured 49%, Rajesh Kumar Yadav secured 41%, Birj Kishor secured 40% and Bapi Ghosh secured 50% respectively.

6. The learned senior CGC has also submitted that as per record, the cut-off marks for the candidates are 63% for the OBC category, 61% for the Clerical and 59% for General Candidates. Therefore, it is understood that, none of the petitioners qualified in the said Recruitment test. Hence, I do not find any reason to interfere with this instant writ petition, hence, it is dismissed and the matter stands disposed of.

7. Court master is directed to return the Departmental Proceeding file to the learned senior CGC immediately and to keep in the file the mark sheet produced before the Court today.

8. With the above observations and directions, the instant petition is disposed of.
