JUDGMENT AND ORDER (ORAL)

Heard Mr S. Dey, learned counsel appearing for the petitioner as well as Mr. S.Sen Gupta, learned Govt. Advocate appearing for the respondents.

- 2. It is an admitted case of both the parties that the present petitioner filed two writ petitions i.e. WP(C) No.[SH]107/2013 and WP(C) No.[SH]131/2013 for the same subject matter regarding the election of the petitioner as Secretary, Village Employment Council (For short VEC).
- 3. In the earlier writ petition, i.e. WP(C) No.[SH]107/2013, the grievances of the petitioner was that he was likely to be removed as Secretary, VEC without the process of law.
- 4. While the said writ petition, i.e. WP(C)[SH]107/2013 was pending, the respondents had passed an order for removing the petitioner from the office of the Secretary, VEC by subsequent orders.
- 5. The said orders for removing the petitioner from the office of the Secretary, VEC had been challenged by filing the second writ petition, i.e. WP(C) No.[SH] 131/2013. This WP(C) No.[SH] 131/2013 had already been disposed of by an order of this Court dated 28-5-2013 wherein this Court had set aside the said order for removing the petitioner from the office of the Secretary, VEC and further directed the respondents to conduct fresh election for the Secretary and female members of the VEC within a period of one month from the date of receipt of a certified copy of Judgment and Order.
- 6. In the above factual backdrop, this earlier writ petition, i.e. WP(C) No.107/2013 has become infructuous. Accordingly this writ petition is dispose of as infructuous.
