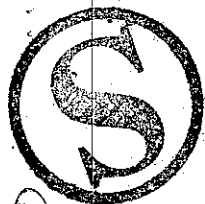

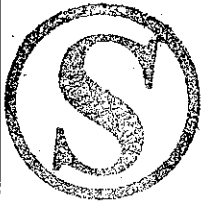

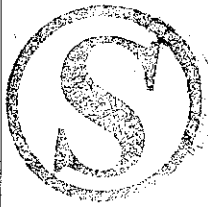

ORDER (OPEN COURT)

(Passed on this 28th day of June, 2013)

Heard learned counsel for the parties.

- 1) The above writ petitions involve common facts and common question of law and, as such, they are being considered and disposed of by this common order.

- 2) Issuance of notice to the respondents is dispensed with, as Shri Verma, learned counsel appears for the respondents and consents for hearing finally.
- 3) At the very outset, learned counsel appearing for the respondents submits that indisputably the money was deposited with the respondent No.3, however, on enquiry and scrutiny it was found that a lot of irregularity was done there and, as such, the documents have been seized. It has been decided by the Samiti to take loan from the respondents No.1 & 2 Bank for disbursal of the amount to the petitioners, however, since a lot of money is involved, six months time may be given to the respondents to disburse the money to all the petitioners with interest.
- 4) Having regarding to the facts situation of the case and considering the fact that the petitioners have been suffering for a long period, the respondents are granted two months time to settle the payment of deposited amount by the petitioners as expeditiously as possible preferably within a period of two months from today.
- 5) It is ordered, accordingly.
- 6) In view of the above, all the writ petitions stand disposed of.
