JUDGMENT

This appeal is by the claimants against the award passed by the Commissioner for Workmen's Compensation, Gulbarga in CR-52/2009 dated 08.09.2010.

- 2. The claimants are the legal representatives of the deceased-Tajuddin. The deceased died in the course of employment on 03/04.04.2009. After inquiry, the Commissioner awarded a compensation of Rs.2,34,820/- with simple interest from the date of the order.
- 3. The grievance of the appellants is that the death of the deceased is during April 2009 whereas the award is passed during 2010. The interest ought to have been awarded from the date of accident/death.
- 4. Having heard, in modification of the award, the claimants are entitled for compensation of Rs.2,34,820/- with interest @ 12% from one month after the date of accident. Accordingly, thie appeal is allowed.
