**ORDER**

The present petition is filed under Section 438 Cr.P.C. seeking anticipatory bail in respect of Crime No.712/2013 on the file of HAL Police Station for the offences punishable under Sections 323, 307 R/w. 149 IPC.

2. Petitioner is accused No.1 in the said case. There are five more accused in the said case and they are already on bail under Sections 438 and 439 of Cr.P.C. passed by the learned Sessions Judge, FTC, Bangalore in Crl. Misc. No.26370/2013, dated 02.12.2013.

3. In the light of the similarly placed accused being already released on bail by the learned Sessions Judge, FTC-III, Mayo Hall Unit, Bangalore, present petition also requires to be allowed.

ORDER

The Petition is allowed. The petitioner shall be released on bail in the event of his arrest in respect of Crime No.712/2013 on the file of HAL Police Station on his executing a personal bond for a sum of Rs.25,000/- with one surety for the likesum to the satisfaction of the Investigating Officer and that he shall not involve in any other criminal activities. He shall co-operate with the Investigation Officer in conducting further investigation.
