**JUDGMENT**

Petitioner's vehicle bearing Registration No.KL-03-T-8353 has been seized by the 2<sup>nd</sup> respondent on the allegation of violation of Kerala Mines Minerals (Regulation of Development) Act 1957. The only prayer of the petitioner is that his application, requesting to allow him to compound the offence and release the vehicle, may be considered. Ext.P3 application is before the 2<sup>nd</sup> respondent. Only the 1<sup>st</sup> respondent District Collector is authorised to compound the offence.

2. Under these circumstances, this writ petition is disposed of directing the petitioner to file an application for compounding before the 1<sup>st</sup> respondent which is directed to be considered within a period of three weeks from today.
