<u>JUDGMENT</u>

The complaint of the petitioner is that the second respondent has put up an unathorised construction encroaching upon a public road, right in front of the petitioner's gate. Though complaints have been submitted to the first respondent, it is contended that no action whatsoever has been taken till date. According to the counsel for the petitioner, the objections of the petitioner were heard on 3rd April, 2012. However, though more than ten months have elapsed, no orders have been passed thereon till date.

2. The counsel for the first respondent submits that in order to ascertain the extent of encroachment, it is necessary to measure the property with the assistance of the Taluk Surveyor. For this purpose, though the petitioner

has approached the Taluk Surveyor, the measurement was not taken place so far. The counsel requests for three months' time for completing the proceedings. The counsel assures that necessary steps would be taken in the matter

as soon as the report of the Taluk Surveyor is obtained.

3. In view of the above, this writ petition is disposed of directing the first respondent to take immediate steps to see that a measurement is conducted by the Taluk Surveyor on an early date and to take necessary action on the petitioner's complaint expeditiously. The measurement shall be completed and the proceedings for removing the encroachment on the public road, if any, shall be completed as expeditiously as possible and at any rate within an outer limit of three months from today.
