### **JUDGMENT**

The petitioners have approached this Court with the following prayers:

- "i) Call for the records, relating to Exts.P1 to P3 and issue a writ or appropriate direction to the respondents 1 to 4 to stop the quarry operating by the 8<sup>th</sup> respondent in violation of the provisions of law and rules as well as the permit conditions.
- ii) Issue a writ or appropriate direction to the 2<sup>nd</sup> and 4<sup>th</sup> respondents to verify the sketch issued by the village officer and ensure that the property of the petitioners shall not be affected by the quarrying operations.
- iii) Issue a writ or appropriate directions to the 7<sup>th</sup> respondent Sub Inspector to take necessary action in the matter.
- iv) Pass any other order or direction as this Hon'ble Court may deem fit and proper in the nature and circumstances of the case."

- 2. The pleadings and proceedings are sought to be rebutted by the 8<sup>th</sup> respondent by filing counter affidavit, also producing copies of the relevant documents.
- 3. The case of the petitioner is that the 8<sup>th</sup> respondent is pursuing quarrying activities without any regard to the permit issued to him and by encroaching even into the nearby village where the property of the petitioner is situated and hence the challenge. The concerned Village Officer has conducted a spot inspection and issued Ext.P5 prohibitory order, despite which, the quarrying operation is being pursued by the 8<sup>th</sup> respondent, which is sought to be intercepted in this writ petition.
- 4. The learned counsel for the petitioner submits that the 8<sup>th</sup> respondent has been granted permit to conduct quarrying operations only in 'Ezhumathoor' village of Mallappally Taluk. Reference is made to Exts.R8( c) series, wherein the survey number of the property has been mentioned with reference to 'Ezhumathoor' village in Mallappally Taluk in Pathanamthitta district. The learned counsel for the petitioner submits that, the petitioner does not have any objection at all in

carrying out the quarrying operation, confining the activity to the said village and the objection is with regard to encroachment to the nearby village i.e. 'Kottangal' village of the very same Taluk.

- 5. The learned counsel for the 8<sup>th</sup> respondent submits that the said respondent is pursuing the activity based on Ext.R3(C) series permits and that the property is situated in 'Ezhumathoor' village.
- 6. After hearing the learned counsel for the parties concerned, the learned standing counsel for the Pollution Control Board and the learned Government Pleader, this Court finds that there is no case for the 8<sup>th</sup> respondent that he is permitted to carry out the quarrying operation in any village other than 'Ezhumathoor' Village and in the particular survey number.
- 7. This being the position, the 8<sup>th</sup> respondent cannot and shall not be permitted to carry out the quarrying operations in 'Kottangal' village under any circumstance. It will be open for the respondents 4 to 6 to ensure that the quarrying operations being pursued by the 8<sup>th</sup> respondent are confined to the particular survey number of the property in 'Ezhumathoor' village and to prevent such exercise, if it extends to

any portion of the nearby 'Kottangal' village. Appropriate action shall be taken, if there is any violation of the permit conditions as well.

Writ petition is disposed of.
