### <u>JUDGMENT</u>

The petitioner is running a driving school and he intends to start a driving school for heavy goods vehicles as well as heavy passenger vehicles. The contention of the petitioner is that though Ext.P2 application was submitted by the petitioner on 26/04/2013 for a licence to start the new driving school so far no action has been taken by the respondent authorities to consider Ext.P2.

- 2. The learned Government Pleader takes notice on behalf of the respondents and submits that there are some cases pending against the petitioner.
- 3. Whatever may be the said circumstances, when an application is received for issuing licence to engage in the business of imparting instructions to drive motor vehicles, the concerned authority is under obligation to pass appropriate orders in accordance with the procedure

prescribed.

In the result, this writ petition is disposed of as follows:

Respondent shall consider Ext.P2 and pass appropriate orders within a period of two weeks from the date of receipt of a copy of this judgment.
