## **IUDGMENT**

The only grievance of the petitioner is to disburse the entire amounts awarded as per Ext.P1. It is the submission of the petitioner is that though the gratuity amount has been disbursed, the interest granted under Ext.P1 has not been disbursed to him. The learned counsel for the petitioner also places before me a common judgment of this Court in W.P(C) No.9928/2011 and connected cases.

2. The learned Standing Counsel for the respondent Board undertakes to comply with the dictum laid down in the said judgment, provided some time, as has been granted in that judgment, is granted to them. In the circumstances, there shall be a direction to grant the entire amount ordered as per Ext.P1, i.e, more specifically the interest granted within a period of six months from today. If the payment is made within the above period, the interest shall run only up to 23.4.2013, the date of deposit of the gratuity amount and if not paid within six months, the interest shall run till the date of payment.

Writ petition is disposed of.
