JUDGMENT

SIRI JAGAN, J.

W.P.(Crl)182/2013 is filed by the father of Ms.Sneha Anna Joseph, who is a minor aged 17 years. He has filed the writ petition alleging that the fourth respondent has abducted his minor daughter and therefore seeks the following reliefs:

- (i) to issue a writ of Habeas Corpus commanding the respondents 1 to 4 to produce the body of the detenue, Ms. Sneha Anna Joseph, the daughter of the petitioner, before the Honurable Court;
- (ii) to issue a writ of mandamus or any other appropriate writ, order or commanding the third respondent to arrest the fourth respondent and proceed against him for abduction of the minor daughter of the petitioner, Ms. Sneha Anna Joseph and also for such other offences punishable under the Indian Penal Code;
- (iii) award to the petitioner the costs of these proceedings and;
- (iv) to grant such other and furthe reliefs as are just, proper and necessary or may be prayed for.
- 2. W.P.(Crl.)196/2013 is filed by the father of the fourth respondent in the other writ petition. He has filed the writ petition alleging that his son is missing.
