PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner/Accused was arrested and remanded to judicial custody on 12.06.2013, for the alleged offence punishable under Sections 366(A) of I.P.C., in Crime No.81 of 2013 on the file of the respondent police and hence, seeks bail.

2.The learned counsel appearing for the petitioner would submit that after the dismissal of the earlier application dated 04.07.2013 in Crl.O.P (MD) No.10135 of 2013, investigation is over and the charge sheet is yet to be filed for want of medical report and hence, he prayed for enlargement on bail.

2.The learned Government Advocate (criminal side) would fairly concede that the investigation is over and they are awaiting for the medical report and he prayed for the dismissal of the application.

3.Considering the facts and circumstances of the case, after the dismissal of the earlier application dated 04.07.2013 in Crl.O.P(MD) No.10135 of 2013, investigation is over and the charge sheet is yet to be filed for want of medical report and hence I am of the view that there is changing circumstance and therefore, I am inclined to grant bail to the petitioner with certain conditions.

5.Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.IV, Trichy and on further condition that the petitioner shall report before the learned Judicial Magistrate concerned daily at 10.30 a.m. until further orders. .
