PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioners, who are arrayed as accused Nos.1 to 4, pray for the grant of anticipatory bail under Section 438 of Cr.P.C. for offences punishable under Sections 294(b), 341 and 506(i) IPC in Crime No.187 of 2013 on the file of the respondent police.


2. The case of the prosecution is that the petitioners have polluted the property of the de-facto complainant and using the same unauthorisedly. When questioned the same, the petitioners abused the de-facto complainant and threatened him with dire consequences.

3. Heard the learned Government Advocate (Crl. Side) who would object to grant the relief of anticipatory bail.

4. On consideration of the facts and circumstances of the case and the submissions made, this Court is of the view that the petitioners can be granted the relief prayed for and accordingly;

(a) In the event of arrest by or on appearance before the respondent police;

(b) In the event of appearance before the learned Judicial Magistrate No.1, Kumbakonam within 15 days from the date of receipt of copy of the order,



(i) the petitioners shall be enlarged on bail on each of them executing a bond for Rs.10,000/- (Rupees ten thousand only) with two sureties each for the like sum to their satisfaction;

(ii) the petitioners 1 to 3 shall be available for interrogation by the respondent police daily at 10.30 a.m. for two weeks and thereafter as and when required and the fourth petitioner, being woman, shall be available for interrogation as and when required.
