PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioner apprehends arrest at the hands of the respondent police for alleged offences punishable under Sections 420 of IPC in Crime No.200 of 2013 on the file of the respondent police and hence, he has come forward with this petition seeking anticipatory bail.

- 2.Learned counsel for the petitioner submits that the petitioner is an innocent person and the petitioner stands falsely implicated. He would further submit that he is nothing to do with the alleged offence as stated in the complaint.
- 3.Learned Government Advocate (Crl.side) submits that while the respondent police intercepted a vehicle, it came to light that without valid licence and permit, four unit of sand is taken from the lake near the petitioner's house and transported, which was seized.
- 4. Considering the facts and circumstances of the case, this Court is inclined to grant anticipatory bail to the petitioner.
- 5.Accordingly, the petitioner is ordered to be enlarged on bail in the event of his arrest or on his appearance, within a period of fifteen days from the date of receipt of a copy of this order, before the learned Judicial Magistrate, No.IV, Trichy, subject to the following conditions:-
- (i) on further condition that the petitioner shall pay a sum of Rs.1,000/- (Rupees one thousand only) towards the Chief Justice Relief Fund; and
- (i) The petitioner shall execute a bond for a sum of Rs.10,000/-https://hcservices.ecourts.gov.in/hcservices/ (Rupees Ten thousand only) with two sureties each for the like sum to the satisfaction of the arresting officer or to the satisfaction of the learned Magistrate concerned; and

(ii) The petitioner shall appear before the respondent police for a period of two weeks every day at 10.30 a.m. and thereafter as and when required for interrogation.
