PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioners, who were arrested by the respondent police on 7/12/2013 for the alleged offence under Sections 147, 148, 153 (a), 341, 294 (b), 353 and 307 IPC r/w. 3 (1) of TNPPDL Act in Crime No.332 of 2013 on the file of the respondent police, seeks bail.

- 2. The learned counsel for the petitioners submits that the petitioners are innocent and they have not committed any offence.
- 3. Learned Government Advocate(Crl. Side) has strongly objected to grant bail to the petitioners.
- 4. I have carefully considered the rival contentions put forward by either side and also perused the materials available on record.
- 5. Considering all these facts and also considering the fact, I am inclined to grant the relief of bail to the petitioners. Accordingly, the petitioners are directed to be released on bail on their executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Pattukottai, and on further condition that the petitioners shall stay at Madurai shall appear before Tallakulam Police Station daily at 11.00 a.m., until further orders.
