PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offence alleged under Section 366(A) IPC.

3. A.1 is alleged to have kidnapped a minor girl aged about 17 years. Both belongs to Ulagampatti in Sivagangai District. On a day, the girl and the boy were missing. Naturally suspicion fell on the boy. In the circumstances, the father of the minor girl lodged a police complaint and also Habeas Corpus Petition for the production of his daughter. In the meanwhile, the minor girl has been secured and produced before the Judicial Magistrate, Tirupattur. The girl gave statement that she went along with the boy on her own volition. This was recorded and the girl was handed over to her parents.

4. A.1 is the main accused. He has been arrested and he is in jail. First petitioner is father of A.1. Second petitioner is his close relative, while A.3 is a close friend of A.1.



6. As against the petitioners, since there is no serious allegation, I am inclined to grant anticipatory bail to the petitioners.

7. (i). Anticipatory Bail is granted.

(ii). Petitioners shall surrender before the learned Judicial Magistrate, Thiruppathur within fifteen days from the date of receipt of a copy of this order.

(iii). Petitioners shall execute a bond of Rs.5,000/- (Rupees Five thousand only) each with two sureties each for a like sum to the satisfaction of said Magistrate.

(iv). Petitioners shall report before the Investigating Officer as and when required for interrogation.
