PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1.Petition for anticipatory bail.

2.Offences alleged are under Sections 465, 467, 468, 471 and 420 IPC in Crime No.7 of 2013.

3.Petitioner is A.1. There are seven accused. Originally, the property belonged to the grand father of A.1. He is the title holder of the property. It is alleged that suppressing the previous conveyance, A.1 executed a power deed in connivance with co-accused.

4.The case is based on documentary evidence. Co-accused were granted anticipatory bail.

5.In the facts and circumstances, I am inclined to grant anticipatory bail to the petitioner.

6. (i). Anticipatory Bail is granted.

(ii). Petitioner shall surrender before the learned Judge, Special Court for Anti Land Grabbing, Tirunelveli, within fifteen days from the date of receipt of a copy of this order.

(iii). The petitioner shall execute a bond of Rs.5,000/- (Rupees Five thousand only) with two sureties each for a like sum to the satisfaction of said Judge.

(iv). Petitioner shall report before the Investigating Officer on every Monday and Friday at 10.30 a.m. for two weeks and thereafter as an when required for interrogation.
