PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offences alleged are under Sections 419, 420 and 506(ii) I.P.C.

3. The matter relates to Deepam Thanga Nila Self Help Group.

4. The learned Government Advocate (Criminal Side) submits that there are 23 victims and total amount involved is Rs.4 lakhs.

5. It has been pointed out by the learned counsel for the petitioner that A-1 has already been granted bail and the petitioner worked under A-1 and not financially benefitted.

6. In the facts and circumstances of the case, I am inclined to grant anticipatory bail.

7. (i) Anticipatory Bail granted.

(ii) Petitioner shall surrender before the learned Judicial Magistrate, Uthamapalayam within fifteen days from the date of receipt of a copy of this order.

(iii) Petitioner shall execute a bond of Rs.5,000/- (Rupees Five thousand only) with two sureties each for a like sum to the satisfaction of said Magistrate.

(iv) Petitioner shall report before the respondent Police on every Monday and Friday at 10.30 a.m., for three weeks.
