ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offences alleged are under Sections 406, 420, 468, 294(b), 506(ii) I.P.C.

3. The matter relates to property.

4. It is also alleged that some forged documents have been created and an attempt has been made to grab temple lands.

5. One Nagaraj / A-1 is the main accused.

6. The learned Government Advocate (Criminal Side) submits that a petition has been received and it is being enquired into.

7. Considering the above aspects and in view of the on going enquiry, there is apprehension of arrest.


8. In the said circumstances, I am inclined to grant anticipatory bail.

9. (i) Anticipatory Bail granted.

(ii) Petitioners shall surrender before the learned Judicial

Magistrate No.1, Madurai within fifteen days from the date of receipt of a copy of this order.

(iii) Each petitioner shall execute a bond of Rs.5,000/- (Rupees Five thousand only) with two sureties each for a like sum to the satisfaction of said Magistrate.



(iv) Petitioners shall report before the respondent Police on every Monday and Friday at 10.30 a.m., for two weeks.
