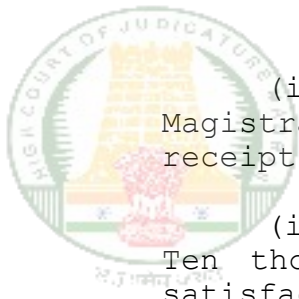

PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

- 1.Petition for anticipatory bail.
- 2.Offences alleged are under Sections 294 (b), 147 and 506 (i) IPC.
- 3.The matter relates to conducting of temple festival. There are two groups. Each is not liking the other. Naturally, there is quarrel. In the circumstances, the defacto complainant alleged that petitioners have abused him in filthy language.
- 4.The learned Government Advocate (Criminal Side) would submit that no one is injured. Festival is over.
- 5.In the light of the above, I am inclined to grant them anticipatory bail.
- 6.(i).Anticipatory Bail granted.



(ii).Petitioners shall surrender before the learned Judicial Magistrate No.I, Tuticorin within fifteen days from the date of receipt of a copy of this order.

(iii).Petitioners shall execute a bond of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of said Magistrate.

(iv).Petitioners shall report before the respondent Police as and when required for interrogation.
