PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offences alleged are under Sections 147, 148, 294(b), 323, 452, 427 and 506(ii) I.P.C in Crime No.149 of 2013.

3. Mr.D.Senthil, learned counsel for intervenor is granted leave.

4. Heard both sides.


5. According to the learned counsel for the petitioners, the petitioners were implicated and the injured has been discharged from the hospital.

6. According to the learned counsel for the intervenor, through Court possession has been taken on 07.05.2013. Subsequently, the disgruntled, and disappointed petitioner with his henchmen attempted to regain possession, he had assaulted the defacto complainant.

7. The learned Government Advocate(Crl. Side) submits that the injured has been discharged from the hospital.

8. There were continuous legal battle as between the de-facto complainant and the petitioners with regard to taking delivery of possession of a property. In this backdrop of the matter, the offence is alleged to have been taken place. The weapon alleged to have been used is a stick. The seat of the injury and the size of the injury are also



noted. In the facts and circumstances, I am of the view that it does not warrant their custodial interrogation.

9. In the facts and circumstances, I am of the view that the petitioners can be granted anticipatory bail.

10. (i) Anticipatory Bail granted.

WEB COPY (ii). Petitioners shall surrender before the learned Judicial Magistrate, Paramakudi within fifteen days from the date of receipt of a copy of this order.

(iii). Each Petitioner shall execute a bond of Rs.5,000/- (Rupees Five thousand only) each with two sureties each for a like sum to the satisfaction of said Magistrate.

(iv). Petitioners shall remain in Madurai and report before the Inspector of Police, Tallakulam Police Station daily at 10.30 a.m., until further orders.
