PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offences alleged are under Section 304(b) and 498(A) IPC in Cr.No.401 of 2013.

3. First accused/A1 is the husband of the deceased. They have no issues. Problem arose between them. It is alleged that there were demand of dowry. In the circumstances, on 29.04.2013, she committed suicide, within seven years of her marriage. It is alleged that soon before her death, she was subjected to dowry harassment.

4. A1 is the main accused. He has already been arrested and he is in jail. Rajeswari and Lalitha/petitioners are related to A1. In the meanwhile, A2 and A4, who are in-laws of the deceased have been granted custody bail. Rajeswari is living somewhere in Sivagangai. While Lalitha/second petitioner lived in the joint family.

5. Considering these aspects, I am inclined to grant them anticipatory bail.

6. (i). Anticipatory Bail granted.

(ii). Petitioners shall surrender before the learned Judicial Magistrate NO.I, Sivagangai, within fifteen days from the date of receipt of a copy of this order.

(iii). Each Petitioner shall execute a bond of Rs.5,000/- <https://hcserVICES.RouPES.ServES/Services> thousand only) with two sureties each for a like sum to the satisfaction of said Magistrate.



(iv). Petitioners shall report before the respondent Police every Monday and Friday at 10.30 a.m. for a period of four weeks.
