PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1. Petition for anticipatory bail.

2. Offences alleged are under Sections 294(b), 420 and 506(i) I.P.C.

3. Heard both sides.

4. Petitioner and the de-facto complainant are partners in friendship as well as business. Dispute arose between them. They have become estranged partners. In this backdrop of the matter, the de-facto complainant lodged the complaint.

5. In the facts and circumstances, I am inclined to grant anticipatory bail to the petitioner.

6. (i) Anticipatory Bail granted.

(ii). Petitioner shall surrender before the learned Judicial Magistrate No.I, Madurai within fifteen days from the date of receipt of a copy of this order.

(iii). Petitioner shall execute a bond of Rs.5,000/- (Rupees Five thousand only) with two sureties each for a like sum to the satisfaction of said Magistrate.



(iv). Petitioner shall report before the respondent police as and when required for interrogation.
