PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

1.Petition for anticipatory bail.

2.Offences alleged are under Sections 8(c) read with 20(b)(ii) (B) of N.D.P.S Act in Crime No.46 of 2013.

3.Heard both sides.

4. The learned Government Advocate(Crl. Side) brought to our notice that the petitioner was found in possession of 6 kgs of ganja.

5. It has been submitted by the learned counsel for the petitioner that it is a small quantity. This has not been disputed by the prosecution. However, it is stated that the petitioner has one previous case.

6. In the facts and circumstances, I am inclined to grant anticipatory bail to the petitioners.

7 . (i) Anticipatory Bail is granted.

(ii). Petitioner shall surrender before the Special Court for N.D.P.S Act cases, Madurai, Madurai District within fifteen days from the date of receipt of a copy of this order.

(iii). Petitioner shall execute a bond of Rs.10,000/- (Rupees Ten thousand only) with two sureties each for a like sum to the satisfaction of said Judge.
