Prayer: Petition filed under Article 226 of the Constitution of India praying for the issuance of a writ of Mandamus to direct the respondents to give permission and police protection for the cultural programme to be conducted on 30.06.2013 at about 07.00 p.m., in front of the Arulmigu Mariamman Temple, Muthapudayanpatti Hamlet, Kannudayanpatti Village, Manapparai Taluk, Tiruchirappalli District.

## <u>ORDER</u>

Mr.Aayiram K.Selvakumar, learned Government Advocate takes notice for the respondents.

- 2. By consent, the writ petition itself is taken up for final disposal.
- 3. According to the petitioner, he has given the representation to the respondents for permission to conduct the cultural programme. However, the said representation has not been considered so far and hence, the present writ petition has been filed.
- 4. The learned Government Advocate appearing for the https://hcservicespoints/poservicesp instructions, would submit that there is no likelihood of law and order problem during the said cultural programme and he has no serious objection for granting permission to grant permission for the same.

- 5. Considering the facts and circumstances of the case and also considering the submission of the learned Government Advocate appearing for the respondents, the third respondent police is directed to take into consideration the ground realities and grant permission for conducting the above said cultural programme, subject to the following conditions:
  - (i) There should not be any kind of obscene or vulgar dance during the performance by anyone of the participants;
  - (ii) The dance programme should be restricted between 06.00 p.m. and 10.00 p.m., on 30.06.2013;
  - (iii) if there is any violation, the concerned Police Officer is permitted to take necessary action as per law and stop such performance;
  - (iv) The petitioner should not put up any kind of flex boards or hoardings during the said cultural programme; and
  - (v) Similarly, the police is entitled to stop the dance programme, if it exceeds beyond the permitted time.
  - 6. The Inspector of Police, Manapparai Police Station, Manapparai, Tiruchirappalli District, is directed to issue permission incorporating the above conditions positively by 05.00 p.m., on 29.06.2013.
  - 7. The writ petition is disposed of with the above directions. No costs.
