High Court may be pleased to release the petitioners/accused No. 1
& 2 on bail pending enquiry and trial on the file of the Judicial First
Class Magistrate, Kamalapuram in Crime No. 134 of 2013 of
Yerraguntla Police Station, Kadapa District.

The Court made the following Order:

**“Heard the learned counsel appearing for the petitioners and
the learned Additional Public Prosecutor representing the State.**

**This criminal petition is filed under Sections 437 and 439 of
the Code of Criminal Procedure seeking bail to the petitioner.**

**Basing on the report lodged by the de facto complainant, a
case in Crime No.134 of 2013 of Yerragunta Police Station has
been registered for the offences under Sections 341, 506 IPC
and Section 3(1)(x) of SC & ST (POA) Act, 1989.**

Perusal of the F.I.R. shows that the offence under Prevention of Atrocities Act is not attracted. Therefore, the petitioner can be granted bail.

The petitioner shall be enlarged on bail on his executing a personal bond in a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties for a like sum each to the satisfaction of the Judicial First Class Magistrate, Kamalapuram.”
