2. The application is disposed of.

3. The parties who are related to each other have on the terms and conditions set out in the application settled their disputes not only subject matter of this suit but also relating to other proceedings/complaints *inter se* the parties.

4. The application is stated to be signed by the parties and their respective counsels and accompanied by their affidavits.

5. The compromise contained in the application is found to be lawful.

6. The application is allowed.
