Heard learned counsel for the petitioners and learned counsel for the State.

These petitions are for grant of regular bail in a case under Sections 461 and 379 of the Indian Penal Code.

It is submitted that the name of petitioners finds place on the basis of confessional statement of co-accused, namely, Sanjay Pahari.

Learned counsel for the petitioners submits that the petitioners are in jail custody since 13.07.2014 and have no criminal antecedent except petitioner Shyam Kumar Yadav who is also accused in two other cases i.e. Darbhanga Sadar P.S. Case No. 151 of 2011 registered for the offence under Sections 302/34 of the Indian Penal Code and Darbhanga Sadar P.S. Case No. 57 of 2012 registered for the offence under Sections 279, 337 and 332 of the Indian Penal Code.

Hence, having regard to the facts and circumstances of the case, the petitioners above named are ordered to be released on bail on furnishing bail bond of Rs.10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of learned Chief Judicial Magistrate, Darbhanga in connection with Sadar P. S. Case No. 248 of 2014.
