ORAL ORDER

2 31-07-2014 Since all the three applications arising out of one case,

they are being taken up together and are disposed of by this

composite order.

Heard the parties.

The three petitioners, apprehending their arrest in connection with a case registered for the offence punishable under Sections 420, 406, 409 and 120B/34 of the Indian Penal Code, are named accused in this case with allegation of committing some irregularities in execution of government schemes and caused monetary loss as stated against their respective names.

Submission is of false implication and the petitioners, namely, Raushan Kumar and Ranjeet Kumar Raut (Cr. Misc. Nos. 20012 and 24236, both of the year 2014) have already deposited the amount respectively Rs. 6294/- and Rs. 14896/- and the petitioner, namely, Subhas Jha (Cr. Misc. No. 24249 of 2014) (Ex-Mukhiya), who is held liable and directed to pay/deposit Rs. 185288/- undertakes to pay/deposit the amount very soon. Further, the petitioner, namely, Raushan Kumar (Cr. Misc. No. 20012 of 2014), carries one case against, i.e., Bheja P.S. Case No. 14 of 2014, petitioner, namely, Subhas Jha (Cr. Misc. No. 24249 of 2014), carries no criminal antecedent, whereas, petitioner, namely, Ranjeet Kumar Raut (Cr. Misc. No. 24236 of 2014), carries four cases against, i.e., (i) Complaint Case No. 775 of 2005, (ii) Complaint Case No. 686 of 2005, (iii) Madhepur P.S. Case No. 177 of 2005 and (iv) Madhepur P.S. Case No. 6 of 2009, wherein, he is on bail.

If it is so, in the event of filing duly verified applications by the petitioners supported with personal affidavit before the court below stating their intentions/deposit the amount in court/proof of deposit, in the event of petitioners, namely,

Raushan Kumar and Ranjeet Kumar Raut (Cr. Misc. Nos. 20012 and 24236, both of the year 2014), arrest or surrender before the court below within four weeks and in the event of petitioner, namely, Subhas Jha (Cr. Misc. No. 24249 of 2014), arrest or surrender and deposit of amount before the court below within eight weeks, let the petitioners abovenamed be enlarged on bail on furnishing bail bonds of Rs. 10,000/- (Ten Thousand only) each with two sureties of the like amount each to the satisfaction of Additional Chief Judicial Magistrate, Jhanjharpur, Madhubani, in connection with Madhepur P.S. Case No. 8 of 2014, subject to condition laid down under Section 438 (2) of the Code of Criminal Procedure with additional condition to remain physically present before the court below on each and every date at least for two years or till disposal of the case, whichever is earlier and in case of failure on two consecutive dates without giving any reasonable explanation or **on any violation of the undertaking,** the liberty granted shall be deemed to be cancelled.
