> Science teacher, serving in Jawahar Navodaya Vidyalaya, Chhindwara in the State of Madhya Pradesh. He has filed this writ petition asserting that Respondent No. 6, Principal, Jawahar Navodaya Vidyalaya, Nawanagar, Buxar, Bihar in collusion with Respondent No. 7, Staff Nurse serving in the



dispensary of Jawahar Navodaya Vidyalaya, Nawanagar, Buxar has interpolated the entries in the service-book of Respondent No. 7 changing the date of birth of her two daughters so as to enable her to obtain Child Care Leave securing illegal benefit amounting to Rs. 7 lacs. In this connection, petitioner asserts that perusal of the Service Book of Respondent No. 7 would indicate that by applying whitener, date of birth of the two daughters of Respondent No. 7 has been altered so as to place Respondent No. 7 in such position that she can avail the benefit of Child Care Leave and illegally earn the aforesaid amount.

2. In the light of the submission noted above this Court asked the petitioner whether in case of genuine mistake having been committed while entering the date of birth of the two daughters in the service-book can the same be not corrected by applying whitener, petitioner then submitted that illegal gratification to the tune of Rs. 1,00,000/- has been paid to Respondent No. 3, retired Deputy Commissioner of the Navodaya Vidyalaya Samiti while he was in service by the parents of one Sunita Singh for securing her transfer from Jawahar Navodaya Vidyalaya, Ranchi to Patna. It is submitted that in the matter of illegal transfer pursuant to receipt of

gratification, investigation by the departmental vigilance is in progress for the last two years.

- 3. From the aforesaid submission of the petitioner, it is quite evident that petitioner is making wild allegation against all concerned. In case petitioner has any personal grudge against Respondent Nos. 3, 6 or 7, he should be well advised to take appropriate legal remedy in accordance with law. Present matter does not involve any Public Interest Litigation.
- 4. In the circumstances, the writ petition is dismissed.
