JUDGMENT AND ORDER

(ORAL: Hon'ble Prafulla. C. Pant, Chief Justice)

- This Public Interest Litigation (for short PIL) was entertained in respect of alleged illegal coal mining in village Diemshalalu in Jaintia Hills of State of Meghalaya.
- 2. After hearing the concerned parties, the Division Bench of Gauhati High Court consisting of Hon'ble the Chief Justice Mr. A.K.Goel and Hon'ble Mr. Justice N. Kotiswar Singh, passed a detailed order on 1-10-2012 in this petition relying on the judgments of M.C.Mehta vrs Union of India (2009) 6 SCC 142, Lafarge Umiam Mining Private Limited vrs Union of India, (2011) 7 SCC 338, Deepak Kumar vrs. State of Haryana, (2012) 4 SCC 629, Samaj Parivartan Samudaya vrs State of Karnataka, (2012) 7 SCC 407, Indian Council for Enviro-Legal Action vrs Union of India, (1996) 5 SCC 281, Essar Oil Ltd. Vrs Halar Utkarsh Samiti, (2004) 2 SCC 392 and Vellore Citizens' Welfare Forum vrs Union of India, (1996) 5 SCC 647.
- In compliance of said detailed order passed by the Gauhati High Court in this PIL, affidavit on behalf of State of Meghalaya was

filed by C.K.Marak, Under Secretary with the Mining and Geology Department, Govt. of Meghalaya on 15-11-2012, and another affidavit was filed by L.M.Sangma, Law Secretary to the State Government regarding steps taken in the matter.

- 4. Apart from the above, since at present the matter pertaining to coal mining in the State of Meghalaya is pending before the Green Tribunal constituted after the order dated 1-10-2012, was passed, therefore, we are of the view that this PIL deserves to be closed now.
- 5. Accordingly, this PIL is closed without further orders.
