### ORDER

## HON'BLE PRAFULLA. C.PANT, CHIEF JUSTICE

Shri SP Roy, Advocate, present for the petitioners.

Shri ND Chullai, Sr. Govt. Advocate, assisted by Shri KP Bhattacherjee, Govt. Advocate, present for the respondents.

- 1. Heard.
- 2. By means of this writ petition, the petitioner has sought direction to the respondent No. 2, Deputy Commissioner (Revenue), Ri-Bhoi District, to

dispose of the application moved by the petitioner for permission to transfer land by Shri John Lmurang (a member of Schedule Tribe of Meghalaya) to

the petitioners (a Society registered under Society Registration Act) for

setting up of a school for children.

3. Section 3 of the Meghalaya Transfer of Land (Regulation) Act, 1971,

provides that no land in Meghalaya shall be transferred by a tribal to a non-

tribal except with the previous sanction of the competent authority.

4. Learned counsel for the petitioner drew attention of this court to Section 4 of

the Act. Sub-section (3) of said Section provides that every application for

sanction shall be disposed of by the competent authority as early as

possible and no later than six months.

5. It is pointed out that the application for permission (copy as Annexure-2 to

the writ petition) was submitted to the Deputy Commissioner (Revenue), Ri-

Bhoi District, on 8<sup>th</sup> July, 2013. And now more than six months have passed

but the petitioner is still waiting decision on the application. It is further

submitted on behalf of the petitioner that petitioner is Gyan Jyoti Education

Foundation which establishes educational institutions in the backward

areas.

6. In the above circumstances, having heard learned counsel for the parties,

this petition is summarily disposed of directing the competent authority to

decide the application moved by the petitioner within 3(three) months from

the date a certified copy of this order is produced before such authority.
