	S.B.: Hon'ble Shri Justice P. Sam Koshy 26.02.2014 None for the appellant. Shri Anant Bajpai, Panel Lawyer for the State/ respondent. In the instant case the appellant has been convicted for the offence punishable u/s 376(I) of IPC and sentenced to undergo rigorous imprisonment for 7 years with fine of Rs. 500/- in default of payment of fine further rigorous imprisonment for 3 months, vide judgment dated 17.3.05 passed by Sessions Judge, Bilaspur in Sessions Case No. 441/04. The present criminal appeal was admitted by this Court for hearing on 21.04.05. The State Government has produced his report wherein the appellant is shown to have been released from jail on 27.02.2010 after completing his jail sentence and since then there is no representation on behalf of the appellant either in person or through his counsel. In view of the above, it appears that the appellant is not interested to pursue the instant criminal appeal. Accordingly, keeping in mind the view of the Hon'ble Supreme Court in case of D.S. Lahoriya @ Rajeev Sudan @ Vinay Kr. vs. State of Rajasthan, reported in 2007 AIR SCW 7327, the present appeal is dismissed as having become infructuous.
