A.G. for the State.</p> <p>Challenge in the present petition is to the order dated 20.10.14 (Annexure P-1) passed by the respondent No.2 whereby the duty of the petitioner who is working as Forest er has been changed from Lormi Range to Khudia range.</p> <p>Counsel for the petitioner submits that under the garb of assigning new duty his place of posting has been changed and if the order impugned is given effect, the head quarter of the petitioner would also change. It has been argued that the shifting of the petitioner is impermissible pursuant to the letter dated 7.3.12 issued by the Chief Conservator of Forest and therefore the order impugned is bad. However it has been submitted that purpose of filing this petition would be served if at this stage the petitioner is permitted to withdraw this petition with liberty to file representation before the Chief Conservator of Forest. He submits that the Chief Conservator of Forest be directed to decide the representation of the petitioner expeditiously considering all the aspects of the case.</p> <p>State counsel has no objection if the petitioner makes any such representation to the Chief Conservator of Forest, Bilaspur and the same is being decided in accordance with</p>
