



ORAL ORDER

(Passed on 31.01.2014)

1. At the very outset, learned counsel appearing for the parties jointly and fairly submit that the issue involved herein has already been considered and decided by the Division Bench of this Court in Chhattisgarh Rajya Panchayat Vaikalpik Shishak Sangh & others vs. The State of Chhattisgarh & others [W.P. No. 1731 of 2005, decided on 11.8.2010] and other connected matters wherein on the submission of learned Additional Advocate General, the Court disposed of the writ petitions with a direction to take decision as expeditiously as possible. In view of the observations made by the Division Bench of this Court in Chhattisgarh Rajya Panchayat Vaikalpik Shishak Sangh (supra), this petition may be disposed of.

2. Accordingly, the writ petition is disposed of in terms of Chhattisgarh Rajya Panchayat Vaikalpik Shishak Sangh (supra) with a direction that in the event the petitioners submit a fresh representation before the competent authority within a period of one month from today, the said competent authority shall take decision, in accordance with law, on its own merits, as early as possible, preferably within a further period of eight weeks from the date of receipt of representation along with certified copy of this order.
