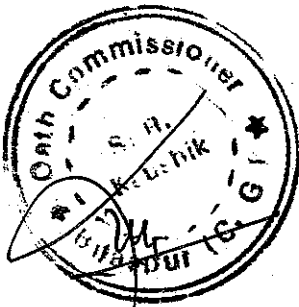

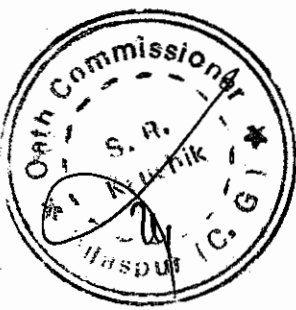

(2) At the very outset, learned counsel for the parties submit that this matter is squarely covered by the order dated 24.02.2012 passed by this Court in W.P. (S) No. 958 of 2012 and pray for passing of similar order as common facts and issues are involved in this petition also.

(3) This Court, while disposing of the aforesaid writ petition, has observed in para 5 of the order dated 24.02.2012 as under :



"3 In view of the statement made above, this petition is finally disposed off with a direction to the respondent authorities to consider and decide the claim of petitioner for grant of two advance increments as per circular dated 21.09.1974 issued by the State of Madhya Pradesh, after verification of the facts pleaded in the petition within a period of three months from today."
