ORDER

This petition is filed under Section 439 of Cr.P.C. seeking bail in Crime No.19/2013 of Miriyan Police Station registered for the offences punishable under Sections 143, 147, 323, 324, 354, 504, 307 r/w Section 149 of IPC. The petitioner is arrayed as accused No.9 in the F.I.R.

2. Co-accused Nos.1 to 4, 7 and 15 are enlarged on bail vide order dated 11.03.2014 in CrI.P.No.200186/2014. The case of this petitioner does not stand distinguished from that of the accused who are already enlarged on bail to reject his prayer. The identity, address and avocation of this petitioner is not in dispute. Under these circumstances, there is no impediment to allow the petition.

3. Accordingly, the petition is allowed. The petitioner is enlarged on bail in Crime No.19/2013 of Miriyan Police Station registered for the offences punishable

under Sections 143, 147, 323, 324, 354, 504, 307 and
Section 149 of IPC, subject to the following conditions:

- (i) He shall execute a self bond for a sum of
Rs.1,00,000/- with one separate surety for
the like sum;
- (ii) He shall not threaten the complainant and
the prosecution witnesses.
