ORDER

Petitioner wife and respondent husband are Medical Doctors by profession, while petitioner practices in Udupi, respondent has his practice at Bangalore. It is the assertion of the petitioner that being wife, she is unable to travel the distance from Udupi to Bangalore, MC No.3434/2013 on the file of the IV Additional Principal Judge, Family Court, Bangalore, instituted by the respondent – husband for dissolution of marriage and that the distance between the two places is about 350 kilometers by road requiring overnight travel and stay at Bangalore.

2. Elsewhere, it is said that it is the convenience of the wife which is important in the matter of transfer of civil petitions.

3. In the result, this petition is allowed.

4. MC No.3434/2013 on the file of the IV Additional Principal Judge, Family Court, Bangalore, is withdrawn and transferred to the Family Court, Udupi.
