ORDER

Petitioner is the 1st accused in Crime No.114/2014 of Rajapuram Police Station, which was registered u/s.395 of IPC. The prosecution allegation is that on 24.03.2014 at 21.10 hours the petitioner and other accused in this case with intention to commit dacoity, snatched the bag of the defacto complainant containing Rs.600/- and thereby committed the offence. On the basis of information, Rajapuram Police registered the above crime and investigation is going on. Petitioner was arrested on 25.3.2014 and remanded to judicial custody. His bail application was dismissed by the learned Magistrate. Hence, he approached this Court for bail.

2. Heard both sides. The learned Public Prosecutor on instructions submitted that investigation is progressing. No other crime is registered against the petitioner. It is submitted

that stringent conditions may be imposed while granting bail.

3. I have perused the case diary and report submitted by the Public Prosecutor. The case records show that witnesses were questioned. The money snatched from the defacto complainant was recovered by the Investigating Officer. Further detention in custody is not necessary. Hence, bail is granted according to the following stringent conditions:

i) Petitioner shall not commit any offence similar to the offence of which he is accused of during this period.

ii) Petitioner shall execute bond for Rs.25,000/- (Rupees twenty five thousand only) each with two solvent sureties each for the like amount to the satisfaction of Judicial First Class Magistrate Court-I, Hosdurg.

iii) Petitioner shall not influence the police or tamper with the prosecution evidence during bail.

iv) Petitioner shall not make any inducement, threat or promise to any person or influence, incite or

intimidate any prosecution witnesses directly or indirectly acquainted with the facts of the case.

v) Petitioner shall appear before the Investigating Officer on every Wednesday between 9 a.m. and 10 a.m. for a period of three months from today.

vi) Petitioner shall not enter the jurisdiction of the Rajapuram Police Station until further orders except for condition No.v specified above.

If the petitioner violates any of the above conditions, the bail granted to them shall be liable to be cancelled by this Court. It shall be open for the investigating officer to approach this court for cancellation of the bail.

The bail application is allowed.
