## ORDER

As per the Order passed by the learned Magistrate, the total monthly amount payable by the husband would come to Rs.8,500/-. Even if it is assumed that a sum of Rs.2,500/- payable to the wife is excluded, the total liability at the rate of Rs.6,000/- per month payable to the children would come to Rs.1,92,000/- (for 32 months). It is stated that Rs.1,00,000/- was already paid.

2. Hence, the petitioner will deposit before the learned Magistrate a sum of Rs.92,000/- (Rupees Ninety Two thousand only), out of which Rs.50,000/- (Rupees Fifty thousand only) shall be deposited within two weeks from today and the balance amount should be deposited within one month thereafter. The amount so deposited shall be

released to the  $1^{\rm st}$  petitioner in M.C. 66/2011, on behalf of minor children.

This Criminal M.C. is disposed of accordingly.
