Heard the learned counsel for the petitioner and the learned Standing counsel for the Calicut University. It is not disputable that the main matter in issue is covered by the judgment of this Court rendered on 22.4.2014 in W.P.(C) 11281/2014. In this case an interim order was passed today to the following effect:

“In the light of the order dated 25.4.2014 passed by this Court in W.P.(C) No.11593/2014, there will be an interim direction directing the respondents to take into consideration Exts.P7 to P53 experience certificates provisionally at the time of the interview of the petitioner. This order will be subject to the final result of the writ petition.”

2. As the main matter in issue is covered by the aforementioned judgment in W.P.(C) 11281/2014, this case is also disposed of on the same lines. The petitioner, who is a CLR (Casual) worker, stakes claim for appointment as peon/watchman. Exts.P7 to P53 experience certificates are

relied on by the petitioner for this purpose. The petitioner has submitted Exts.P54 and P56 representations with the official respondents in this regard.

3. In the facts and circumstances of the case, it is directed that the competent authority among the official respondents shall consider Exts.P54 and P56 representations with due notice to the petitioner. Exts.P7 to P53 experience certificates shall also be adverted to in this exercise. Final orders shall be passed on the aforesaid representations of the petitioner within a period of six weeks from the date of production of a copy of this judgment. The consideration of the experience certificates as ordered in the aforementioned interim order of this Court in this W.P.(C), shall be subject to the final decision to be taken by the official respondents on the aforesaid representations of the writ petitioner.

With these observations and directions, this Writ Petition stands finally disposed of.
