## JUDGMENT

Heard the learned counsel for the petitioner and the learned Government Pleader for the respondents, apart from perusing the Since the issue lies record. in a compass, this Court proposes to dispose of the writ petition at the admission stage itself.

Briefly stated, the petitioner 2. appointed as High School Assistant (English) through Exhibit P1 in retirement vacancy in the School under the management of the respondent. When approval was sought, it was rejected based on the Staff Fixation order of 2010-2011.

- 3. In the face of rejection of the request for approval of the petitioner's appointment, the fifth respondent Manager is said to have preferred Exhibit P7 revision before the fourth respondent questioning the validity of the Staff Fixation Order. On the other hand, the petitioner herself has preferred Exhibit P8 revision impugning the rejection of approval for her appointment.
- 4. The learned Government Pleader, on instructions, has submitted that the fourth respondent has already considered Exhibit P7 revision, but yet to pass orders. In so far as Exhibit P8 revision is concerned, it appears to be still pending.
- 5. In the facts and circumstances, it will meet the ends of justice if the fourth respondent considers Exhibit P8 revision filed by the petitioner along with Exhibit P7 revision filed by the Manager and passes common

orders.

6. Accordingly, this writ petition is disposed of with a direction to the fourth respondent to consider Exhibit P8 revision along with Exhibit P7, and pass appropriate orders thereon, as expeditiously as possible, at any rate, within a period of four months from the date of receipt of a copy of this judgment.

With the above observation, this writ petition is disposed of.
