JUDGMENT

K.Vinod Chandran, J.

The above habeas corpus petition has been filed alleging that the wife of the petitioner had been kept under the illegal custody of the party-respondents herein. The petitioner has also produced a marriage certificate and the photographs of the alleged ceremony of marriage conducted by the petitioner and the alleged detainee.

2. The alleged detainee was produced by the party-respondents and we have talked to her. The alleged detainee, who is a graduate and who is 22 years of age, submits before us, that, she is now residing with her parents, on her own free will. In such circumstance, there is no question of any illegal detention.
