
ORDER : The Court Made the following order :-

The petitioner, who is arrayed as A3, was arrested and remanded to judicial custody on 03.07.2014 for the alleged offences punishable under Sections 341 & 302 of IPC, in Crime No.345 of 2014 on the file of the respondent police and hence, seeks bail.

2.One Karuppanan lodged a complaint alleging that his son Ramkumar @ Ramki was murdered by the accused Nos.1 & 2 namely Peter and Raja on 26.06.2014. The complainant categorically stated that on 26.06.2014 the second accused Raja caught hold of the deceased while the first accused stabbed him indiscriminately.

3.The learned counsel for the petitioner submitted that the petitioner has been implicated only on the basis of the confession of the co-accused and even according to the confession, the petitioner is said to have been watching the movement of the deceased. He further submitted that on the very next day of the occurrence A1 died in mysterious circumstances and the second accused have been secured by the respondent.

5.Considering the nature of allegations made against the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.II, Dindigul and on further condition that the petitioner shall appear before the respondent police daily twice at 10.00 a.m., and 06.00 p.m., until further orders.
