PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioner, who is arrayed as accused, apprehends arrest at the hands of the respondent police for the alleged offence punishable under Sections 465, 467, 468, 471 and 34 of I.P.C. in Crime No.17 of 2014 on the file of the respondent police and hence, seeks anticipatory bail.

- 2. The case of the prosecution is that the brother of petitioner one Ramakrishnan had executed a will in favour of his wife and the petitioner's son and after the death of the said Ramakrishnan, the petitioner's son executed a power of attorney in his favour. On the basis of power of attorney, the petitioner has sold the property in favour of the second accused. The allegation is the sale deed is a forged one.
- 3. The learned counsel for the petitioner submitted that the respondent police had investigated the complaint and closed the same as mistake of fact and subsequently, as per direction issued by this Court, a case has been registered against the petitioner and other accused.
- 4. The learned Government Advocate (Crl. side) would submit that the respondent has registered a case on the basis of direction issued by this Court.
- 5.Considering the nature of allegation made petitioner, this Court is inclined to grant anticipatory bail to the petitioner, with certain conditions. https://hcservices.ecourts.gov.in/hcservices/

- 6.Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance before the learned Judicial Magistrate, Alanthur and on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Magistrate concerned and on further condition that the petitioner shall appear before the respondent police as and when required for interrogation. The petitioner shall comply with the condition stipulated under Section 438 Cr.P.C. scrupulously.
- 7. The petitioner shall appear before the concerned Magistrate within a period of 15 days from the date on which the order copy made ready, failing which, the petition for anticipatory bail stands dismissed.
