PETITION FOR BAIL Under Sec. 439 Cr.P.C.

ORDER: The Court Made the following order:-

The petitioner, who is arrayed as A6, was voluntarily surrendered before the Judicial Magistrate, Valliyoor on 19.06.2014 for the alleged offences punishable under Sections 147, 148, 341, 294(b), 302 and 120(b) of IPC, in Crime No.296 of 2014 on the file of the respondent police and hence, seeks bail.

- 2. The case of the prosecution is that on 18.06.2014 the deceased said to have attacked by A2 and A4 for which, a case was registered against the accused. Due to the motive, on 16.06.2014 the accused Nos.1 to 5 are said to have attacked the deceased with knife and Aruval and caused the death of the deceased.
- 3. The learned counsel for the petitioner submitted that even according to the prosecution, the petitioner is said to have way laid the deceased before the alleged occurrence. He further submitted that the accused, who are having direct overt acts have been arrested and released on bail by this Court in Crl.O.P(MD)No.11564 of 2014 and 12142 of 2014.
- 4. The learned Government Advocate (Crl.side) submitted that major portion of the investigation is over and the respondent has to file a charge sheet.
- 5.Considering the stage of the investigation and the overt act attributed against the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions. Accordingly, the petitioner is ordered to be released on bail and on executing a bond for a sum of

Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Bhoothapandy and on further condition that the petitioner shall appear before the respondent police daily at 10.00 a.m., until further orders.
