The petitioners, who apprehend arrest for the offences punishable under Sections 147, 148, 294(b), 387, 435 and 506(ii) I.P.C. r/w Section 3(1)(4) of TNPPDL Act and Section 3(2), 3(1)(r)(s)(iii) and 3(i)(r)(s) of Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 in Crime No.118 of 2014 on the file of the respondent police, move this petition seeking direction to the the Special Court/learned Principal District and Sessions Judge(PCR), Pudukkottai, to consider the bail applications filed by the petitioners on the same day of their surrender.
- 3. The learned Government Advocate (Crl.Side) submitted that no one sustained injury in the alleged occurrence.
 - 4. Perused the records.

injury in the alleged occurrence, the same can be considered by the said Court on the same day.

- 6. Therefore, the the Special Court/learned Principal District and Sessions Judge (PCR), Pudukkottai is directed to accept the surrender of the petitioners and consider their bail application on the very same day purely on the basis of merits and to pass suitable orders, in the event of petitioners surrendering before the said court within 15 days from the date of receipt of the order and their filing of petition seeking bail.
 - 7. Accordingly, this Petition is ordered.
